Dear Member,

It is noted from the NIPM records / database that you had e-registered / logged-in, **during the period between 16.5.2021 to 09.6.2021 (12.00 noon)**, to incorporate your member's contact details (**e-mail id & mobile number**), for the purpose of enlisting your name for e-voting to the ensuing NIPM Biennial Elections to the N.C.-2021-23.

In this regard, it has been decided to **undertake verification / authentication on random sampling basis of such e-registered/ logged-in members' contact details**, to the extent possible. In this regard, may please note as follows:-

- (i) If the mobile number to be given by you now if any, is different from the mobile number e-registered in the NIPM database as shown against your name, **then the new mobile number to be given by you now, will be considered as your actual mobile number for the purpose of NIPM e-voting, thereby replacing the previously e-registered mobile number, which will therefore be deleted and replaced by your new mobile number.**
- (ii) In case **NO such e-mail reply/confirmation is received from you within Thursday - 15.7.2021:11.30 PM** as requested above, it will have to be presumed that, the said member's e-mail id and / or mobile number purported to have been e-registered / logged-in by you during the period between 16.5.2021 to 09.6.2021 (12.00 noon), were **NOT e-registered/ logged-in by you BUT by anonymous person(s), and that the said member's contact details therefore do NOT belong to you and are NOT genuine.**
- (iii) In the event as referred at (ii) above, the member's said e-registered / logged-in contact details as available in the NIPM records / database, will be **IGNORED as being INCORRECT/ PLANTED data, and thus NOT usable for e-voting purpose by NIPM.
