### **IMPORTANT NOTICE FROM THE CRO**

Date : 19.7.2021

To-

- 1) All concerned NIPM members/ e-registered eligible e-voters ( Thru NIPM Website/ NIPM N.O. Notice Board)
- 2) All NIPM Chapter Chairpersons / Hon. Secretaries- By email
- 3) All Validly Nominated Contestants ( Not Having Withdrawn till date)- By email

Dear NIPM Members,

Sub: **Verification / Authentication drive: 'Chapter Authenticated' contact details of e-registered members/ voters AND Thru emails on Random Sampling Basis of those who logged-in on and after 16.5.2021**

Members are kindly aware that due to the lurking apprehension reg. sudden surge in e-registrations / logging-in by members & concerned Chapter authorities during the very last stages of NIPM e-registration process for e-voting purpose ( consequent to the NIPM NC's decision on 16.5.2021 to permit such e-registrations/ logging-in on and from 16.5.2021 till 09.6.2021 - 12 noon) , the CRO and his team had suo motu initiated verification / authentication drive, initially of the e-mails & mobile nos. in respect of the 503 nos. members' e-registrations done thru the ' Chapter Authenticated' method, out of the 5064 nos. members' list/database received by the CRO from the concerned NIPM authorities.

The STATUS of the said verification / authentication drive undertaken for such 503 nos. members' e-registrations done thru ' Chapter Authenticated' method, IS AS FOLLOWS:-

- 1) Speed Post letters dated 18.6.2021 / envelopes were sent by the CRO to the 503 ( Five Hundred Three) nos. members' postal addresses ( as per the postal addresses provided by the concerned authority of NIPM to the CRO & his team), seeking confirmation from their registered e-mails within 03.7.2021, about the authenticity of their ' Chapter Authenticated' e-registered e-mail ids & mobile nos.
- 2) OUT of the said 503 nos. Speed Post letters sent by the CRO to the ' Chapter Authenticated' list of members , 195 nos. ( One Hundred Ninety Five) such letters have been 'RETURNED UNDELIVERED' by the Postal Dept. ( due to various reasons including apparent faulty/ insufficient postal addresses as existing in the NIPM database and as given to the CRO, which is NOT attributable to the CRO and his team)
- 3) HENCE, ( 503-195)= 308 nos. ( Three Hundred Eight) Speed Post letters were actually DELIVERED to the concerned members' postal addresses (as given to the CRO by the concerned NIPM authorities), for giving necessary e-mail confirmation by them to the CRO within 03.7.2021.
- 4) OUT of the said 308 nos. Speed Post letters DELIVERED to concerned members' postal addresses, ONLY 54 nos. ( Fifty Four) members have RESPONDED within the given last

date- 03.7.2021 / till date, giving the required confirmation about their e-registered emails & mobile nos. and/ or seeking correction thereof.

- 5) HENCE, (308-54)= 254 nos. ( Two Hundred Fifty Four) members have FAILED TO RESPOND / HAVE NOT RESPONDED, in spite of reasonable opportunity being given to them by the CRO vide his Speed Post letters dated 18.6.2021, to verify / authenticate their e-registered contact details viz. e-mails / mobile nos.
- 6) THUS, these 254 nos. members' contact details ( as referred at Sl.5 above ) are palpably unverified / unauthenticated data as regards their e-mails & mobile nos.; THEREFORE based on which obviously suspect data, it will NOT at all be prudent and safe to initiate e-voting process for these 254 nos. members, who DID NOT purposely respond to the CRO's letter dated 18.6.2021.
- 7) ACCORDINGLY, as already stated in the CRO's letter dt 18.6.2021 , the NAMES of these 254 nos. unresponsive purportedly e-registered members thru ' Chapter Authenticated' method, WILL be summarily REMOVED/ DELETED from the e-registered members list of eligible e-voters, for the NIPM Biennial Elections to the N.C: 2021-2023, in view of which these 254 nos. members will NOT be able to participate in the e-voting .

In view of the pathetic response as above by 'Chapter Authenticated' 503 nos. members ( viz. 254 nos. members NOT RESPONDING i.e. about 51% & ONLY 54 nos. members RESPONDING i.e. about 10%) and huge number of Returned Undelivered Speed Post letters ( 195 nos. i.e. about 39%), a drive had thereafter been undertaken by the CRO thru the concerned members' registered emails ( not thru speed post letters) , for Authentication / Verification on Random sampling basis of the mobile nos. of 536 nos. e-registered / logged-in members ( i.e. only from amongst those who logged-in for the FIRST-ever time on and after 16.5.2021 till 09.6.2021).

NEEDLESS to mention, out of the concerned 536 nos. members ( on Random Sampling basis) who do not/ have not responded to this authentication / verification drive thru e-mail, will have their Names REMOVED/ DELETED summarily from the e-registered members list of eligible e-voters, for the NIPM Biennial Elections to the N.C: 2021-2023.

I am giving the full scenario about the Authentication / Verification drives undertaken by the CRO and his team, in order to immediately DISPEL any WRONG NOTION that is being continuously sought to be generated with malafide intention amongst the NIPM members by those having vested interests, that the CRO is NOT taking any action for Authentication / Verification, in spite of his being requested to do so.

THEREFORE, any purported advice NOW being given by the Hon. General Secretary-NIPM to Chapter Chairpersons / Hon. Secretaries, for their undertaking verification / authentication at Chapter-level in respect of logged-in Chapter members, is NULL AND VOID and will NOT be given any cognizance by the CRO/ will be IGNORED by the CRO. Any such verification / authentication if done now by the NIPM Chapter Chairpersons/ Hon. Secretaries at the behest of Hon. General Secretary-NIPM, will NOT be recognised by the CRO for the purpose of revision of members' database, since such authentication / verification, SHOULD HAVE been done if at all by the Hon. General Secretary and his team, well before handing over the list of members' / e-voters by the Hon. General Secretary to the CRO on 12.6.2021, and not thereafter.

FURTHER, this purported verification/ authentication drive NOW being forcibly sought to be undertaken by the Hon. General Secretary thru the Chapter Chairpersons/ Hon. Secretaries, is an ALIBI being created by the Hon. General Secretary to cover up his extreme negligence and failure in preparing a fully verified / authenticated members/ e-voters list till 09.6.2021, before handing over the said list of members' / e-voters by the Hon. General Secretary to the CRO on 12.6.2021.

LASTLY, as a Contestant in this Biennial Elections: 2021-2023, the Hon. General Secretary has NO locus standi to undertake this verification / authentication drive now, as he has NO

**POWERS to do so once he has handed over the voters list to the CRO and Election process has been initiated. As the CRO, I therefore consider that the Hon. General Secretary is surreptitiously doing CAMOUFLAGED CAMPAIGNING for his candidature as National President in this Election, by reaching out CLANDESTINELY to the NIPM electorate thru the Chapter Chairpersons/ Hon. Secretaries, which is ETHICALLY and LEGALLY WRONG on his part.**

**Trust, this absolutely clears the controversial situation as above.**
