### **MINUTES OF THE 41<sup>ST</sup> ANNUAL GENERAL MEETING OF NIPM**

Date : Thursday, the 30<sup>th</sup> September, 2021 (By Virtual Mode through Zoom)

Due to the situation of pandemic Covid-19, the 41<sup>st</sup> Annual General Meeting of NIPM was held by Virtual mode through Zoom.

Mr Vishwesh Kulkarni, National President of the Institute was in the Chair. 100 Life / Corporate Members were participated in this meeting.

National President welcomed all the members of NIPM who had participated through Zoom from different Chapters and also different parts of the country. Before going to the Agenda, National President informed that due to pandemic, the accounts of NIPM National Office are still in the process of being finalised. Further, the Income tax Authorities have extended the time limit for submission of the accounts upto 31<sup>st</sup> December, 2021. He also informed that a Special General Meeting will be held later on wherein the audited accounts and annual report of NIPM will be placed.

National President thereafter proceeded with the other listed Agenda Items, which are as under :

i) **Confirmation of the Minutes of the 40<sup>th</sup> Annual General Meeting held on Sunday, the 20<sup>th</sup> June, 2021 by Virtual Mode through Zoom**

National President opined that the Minutes of the 40<sup>th</sup> Annual General Meeting which was circulated earlier to all members, be confirmed, if there are no observations.
